## NOTICE OF AGM, E-VOTING AND BOOK CLOSURE

**NOTICE** is hereby given that the 26<sup>th</sup> Annual General Meeting (AGM) of **Gowra Leasing & Finance Limited** is scheduled to be held on Tuesday, 24th September, 2019, 11:30 AM at Hotel, Taj Tristar, "Seven Hills" ,1-4-40, S.D. The members may cast their vote electronically through electronic voting system of Karvy Fintech Private Limited from a place other than venue of AGM (remote e-voting). All members are informed that:

- 1. The Ordinary and the Special Business as stated in the Notice of 26<sup>th</sup> AGM may be transacted through voting by electronic means;
- 2. The remote e-voting shall commence on September 21, 2019 at 9.00 am (IST) and end on September 23, 2019 at 5.00 pm (IST);
- 3. The cut-off date for determining the eligibility to vote by electronic means or at the AGM is September 12, 2019;
- 4. Any person, who acquires shares of the Company and becomes a member of the Company after dispatch of the Notice of AGM and holding shares as of the cut-off date i.e. September 12, 2019, may obtain the login ID and password by sending a request at <a href="evoting@karvy.com">evoting@karvy.com</a>. However, if a person is already registered with Karvy Fintech Private Limited for e-voting then existing user ID and password can be used for casting vote;

Members may note that: -

- a) The remote e-voting module shall be disabled by Karvy Fintech Private Limited after the aforesaid date and time for voting.
- b) Once the vote on a resolution is cast by the members, they shall not be allowed to change it subsequently;
